OPERATING INSTRUCTIONS



WARNING

1. Use this product only one person at a time.
2. Do not use this chair unless all rails are secure
3. Check that all rails are tight and secure every three months or as needed.
4. Dispose of packing material properly. Do not use plastic cover as head covering. It may cause suffocation.
5. Do not use chair as a stepladder.
6. Use this chair for its intended purpose only.
7. Use mild detergent only for cleaning.

LIMITED WARRANTY

Office Star chairs are warranted from the date of purchase against failure due to material and workmanship as follows:

- 5 Years on all non-moving metal parts.
- 2 Years on component parts including Control mechanisms, pneumatic cylinders, wood, plastic parts, base and casters.
- 1 Year on upholstery fabric and foam against wear and deterioration.

To make a warranty claim, contact Parts Department. Provide model number, proof of purchase, description of the problem and obtain return authorization. At it's option Office Star Products will:

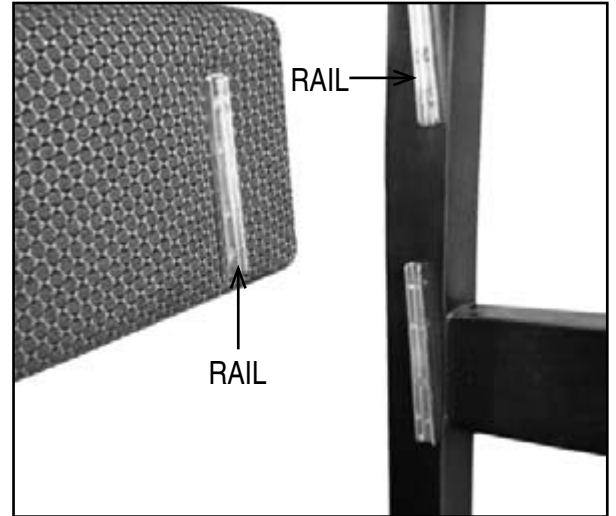
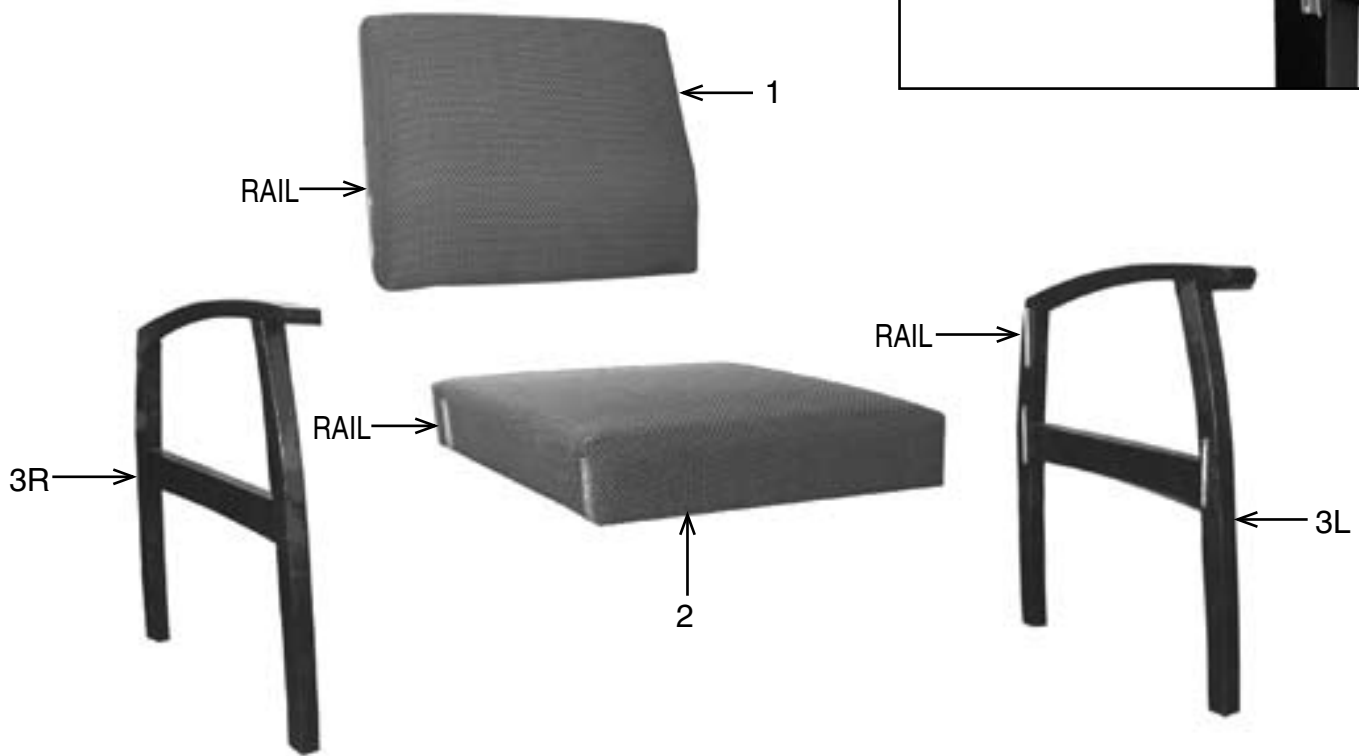
- (a) Supply compatible components of current manufacture.

ASSEMBLY INSTRUCTIONS



PART	QTY
1. Back Cushion	1
2. Seat Cushion	1
3. Arm Frames (3L & 3R).	1

Remove all parts from carton, separate by part numbers indicated on parts list, and verify part quantities.

STEP 1 Attach Seat Cushion (1) to Arm Frames (3L & 3R) by inserting rails of Seat Cushion (1) into rails of Arm Frames (3L & 3R). **SEE DETAIL A.**

STEP 2 Attach Back Cushion (1) to Arm Frames (3L & 3R) by inserting rails of Back Cushion (1) into rails of Arm Frames (3L & 3R). **SEE DETAIL A.**

ATTENTION: MAKE SURE ALL RAILS ARE FULLY SECURE BEFORE USING CHAIR.
